The exceptional two (2) acre site is located at Airport Road and Nevets Road in Brampton. The 5 storey, 250,000 sq. ft. Dymon Storage facility planned for the site will include industrial showroom space. This Brampton site is the first of eighty (80) Dymon Storage facilities planned for the GTA. Upon completion of Dymon's ten (10) year expansion plan for the Toronto area, Dymon will have over 10 million square feet of its industry leading storage facilities.
